The CUES School System is a bold educational initiative providing centralized leadership and governance to three urban elementary schools in Omaha, Nebraska serving a majority of low-income students and families. We combine innovative instructional methods with comprehensive student and family support in a Catholic faith-based environment to create and sustain excellent and measurable outcomes that not only impact the students we serve but also the entire community.

The CUES Fund secures financial support through private donations to fully fund the CUES School System. The school system provides centralized leadership and governance to three urban grade schools: Sacred Heart, All Saints and Holy Name. The CUES Fund is a non-religious, non-profit organization overseen by a Board of Directors.

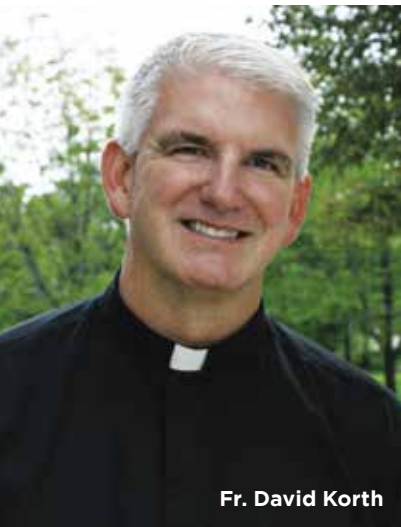

Symone Sanders is a Sacred Heart graduate, a graduate of Mercy High School and Creighton University, where she received a bachelor's degree in business administration.

She worked in the communications department of former Omaha Mayor Jim Suttle and was deputy communications director for Democratic gubernatorial candidate Chuck Hassebrook in 2014. Her career includes serving as the national press secretary to Bernie Sanders during the 2016 presidential primary campaign and an analyst and commentator to CNN.

In 2015, "Fusion Magazine" listed Sanders as one of 30 women under 30 who would shape the 2016 election. In 2019, she joined the presidential campaign of former vice president Joe Biden as senior-advisor. In 2020, she published a memoir, "No, You Shut Up". On November 29, 2020, Sanders was named senior advisor and chief spokesperson for Vice President Kamala Harris.

Symone and her siblings attended Sacred Heart. "Education was and is important to our family and my husband and I chose Sacred Heart because of the excellence of the school in our neighborhood," said her mother Terri Sanders, the publisher of "The Omaha Star" newspaper. "Symone thrived in the Sacred Heart environment and from all her experiences. I believe the most memorable was the mentorship program. At the time she expressed she wanted to be a judge and the school provided her with two female judges as mentors that she still has communications with to this day. I am extremely proud of all of Symone's accomplishments."

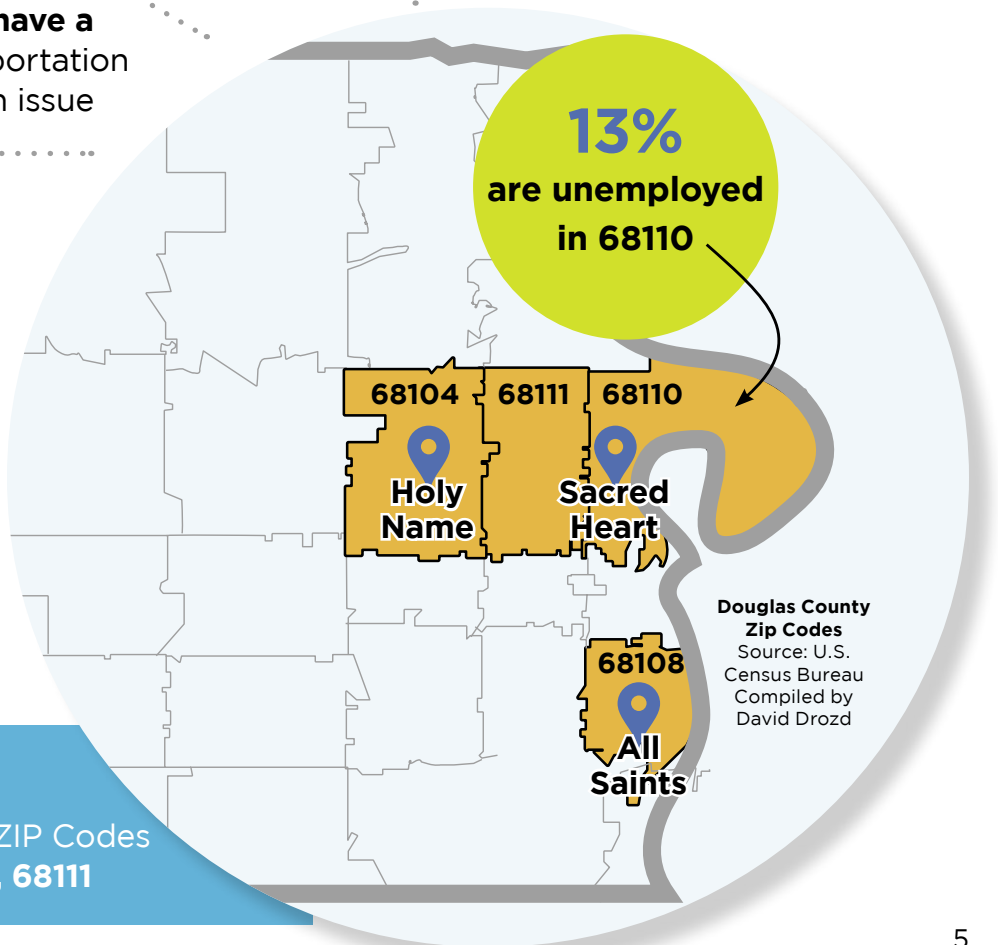

Influence

Teachers are the engine that drive social and emotional learning (SEL) programs and practices in schools and classrooms. Research shows that SEL not only improves achievement by an average of 11 percentile points, but it also increases prosocial behaviors (such as kindness, sharing, and empathy), improves student attitudes toward school, and reduces depression and stress among students.



Strong Curriculum



Students receive a well-rounded education with curriculum that incorporates a strong reading and math emphasis.

- Preschool through 8th grade students are individually challenged based on their academic development
- The Guided Reading Program helps students develop reading strategies to advance their reading level
- Special teachers for music, technology, Spanish, health, and physical education

Impact

We test for learning comprehension through computer-adaptive testing. This methodology tests for current grade comprehension and measures any gaps or excelled achievement. The data is utilized to guide instruction and develop individual plans for each child.

- 43% of all grades tested showed growth in reading
- 38% of all grades tested showed growth in math
- 38% of CUES graduates participated in a mentorship and tutoring program for college entry

CONNECTING TO RESOURCES

CUES Schools System helps to improve each family's circumstances and positively affects home life for students. Our community partnerships help supply families with necessary resources such as food, behavioral health, dental, transportation, utility, and rent assistance. Community partners also support families outside the classroom, with a majority of our students attending an after-school program. Below are some examples of our partnerships.

COMMITTED TO FAMILIES



Gatien Meba moved to Omaha from Togo, West Africa in 2004 to seek higher education. He met his wife, Monica, in Omaha, and they have four sons - Joel, Deklan, Philemon, and Aybel.

The Mebas have been sending their children to Holy Name since 2013 after a neighbor introduced them to the school. Joel is a sixth grader, Deklan a fourth grader and Philemon a second grader. The Meba's three-year old, Aybel, will attend preschool next year.

When asked what the Mebas appreciate most about CUES, Gatien said,

“The teaching and excellent communication between teachers and parents are amazing and the school’s support services help my family plan for the future. There is no other school system like this!”

Gatien attended the “Getting Ahead” program that Jim Swanson, director of student and family support services, recommended as a path forward. The 10-week course helps build resources for a better life. Gatien started a college savings fund for his four children but lost his ability to pay into it when COVID-19 began to affect his ability to work. His hours were reduced to 30 hours per week and there were weeks when there was no work.

Although finances are tight, the Mebas hope the boys will attend college. CUES is connecting the family to scholarship opportunities for Joel. “Mr. Swanson never stops introducing me to resources and opportunities,” said Gatien. “Without CUES support my boys would not be able to attend Holy Name and I would not be connected to community resources which help our family’s future. We are so blessed, and we pray for all those who are working hard to support us.”



WE INSPIRE GREATNESS



In 2019, T'Kaia Butler earned the prestigious Thelma M. Landstrom scholarship, which is awarded annually to one student in the Omaha Archdiocese who demonstrates academic achievement, a compassion for helping others, and the strong desire to succeed. This needs-based grant covers all expenses for the recipient during her entire four years at Marian High School.

A Sacred Heart graduate, T'Kaia credits the CUES system with her passion for learning. “I love Sacred Heart because it feels like one big family,” she said. “I still reach out to my former teachers for help, and I am grateful for all of my teachers and how much they care about academics and how we are doing at home. I’m proud to be an alumna. I wouldn’t trade it for anywhere else.” Now a sophomore at Marian, T'Kaia participates in Upward Bound, a program that focuses on helping students develop their academic skills and achieve the personal growth necessary to succeed in high school and college. She plans to study psychology at Creighton University after graduating from Marian in 2023.

INDIVIDUALIZED EDUCATION SUCCESS

Brothers Nathan and Christopher Mitchell graduated from Holy Name well prepared for the rigors of higher education and the work force. “Holy Name allowed our boys to receive a quality education, which prepared them for their futures. Both boys require a different style of learning, and we feel fortunate that CUES provides individual instruction. And more than anything else, that it lives by its values – love, kindness, and caring.” said their mother, Annie.



After graduating from Holy Name in 2014, Nathan completed the Madonna School’s Transition program, which helps students advance through academics, independent living, career training, community mobility, and recreation. Nathan now works as a general assistant at St. Bernard Catholic Church.

Christopher graduated from Roncalli High School in 2019 and is a sophomore in the music education department at the University of Nebraska Omaha, where he was awarded a Regents scholarship. Armed with a strong work ethic, Christopher teaches piano lessons and runs an after-school music program at Roncalli. He plans to graduate debt-free.

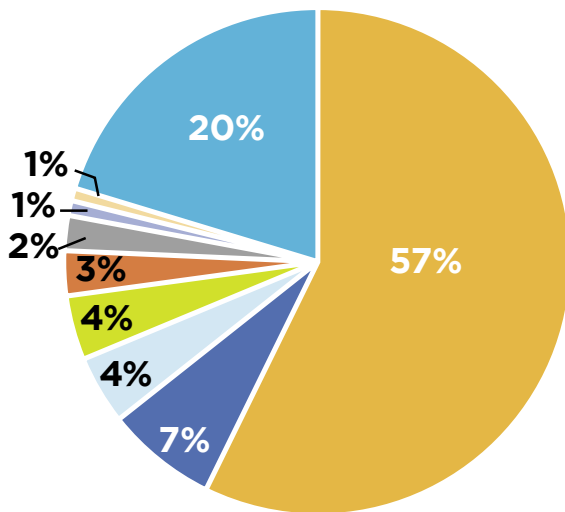
FINANCES AT A GLANCE

The CUES School System works as a team to coordinate centralized services including building and grounds, finances, marketing, operations, student enrollment, teacher recruitment, and technology. Our goal is to remove any obstacle that affects learning, allowing our teachers to focus on instructional leadership. The CUES Fund exists to raise the necessary funds to support school operations. The year ended with \$2,196,943 in net revenue and \$7,438,904 in total assets. The CUES Fund received a one-time revenue payment from the "Payroll Protection Program" to ensure employment for CUES Fund and School System staff. We also received capital funds from the Archdiocese of Omaha.

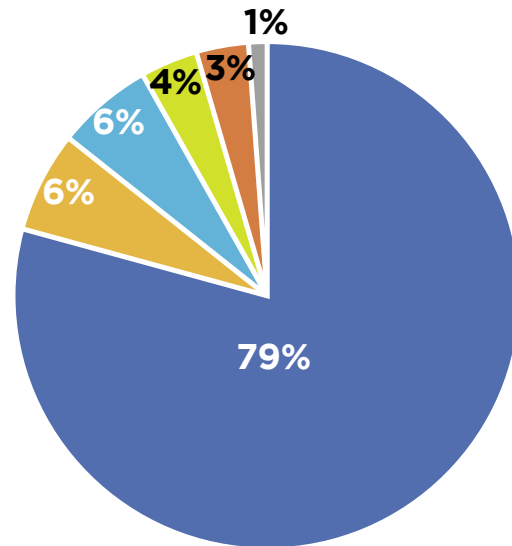

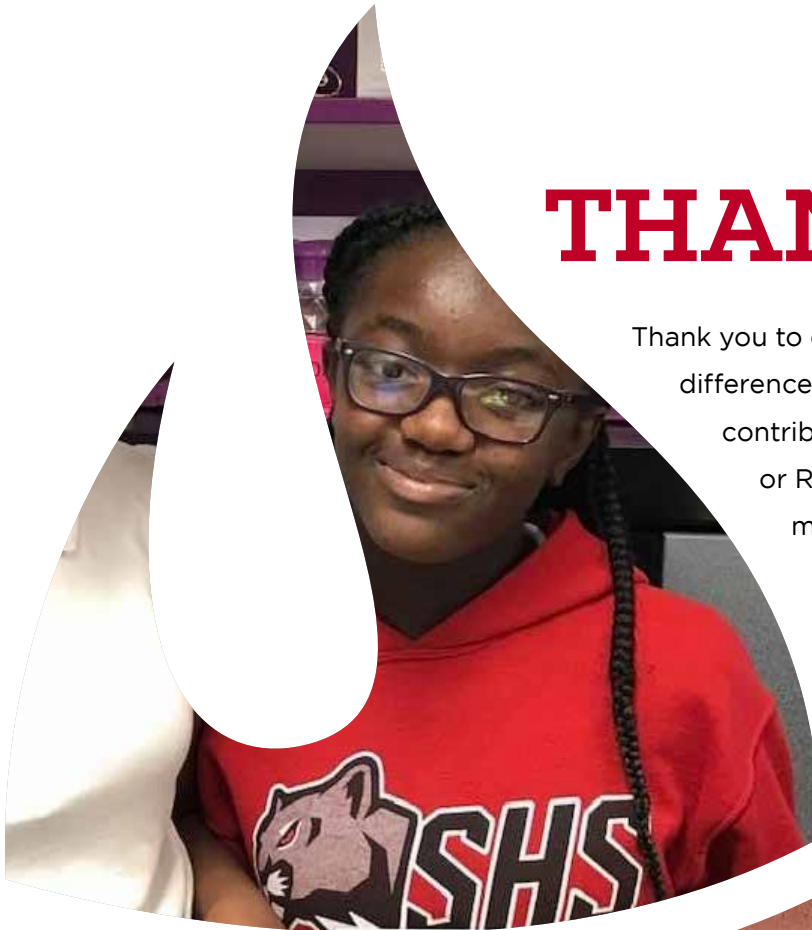
